CFAC Policy Sub-committee Meeting's Agenda and Recap:

The CFAC Policy Sub-committee meeting began with introductions and updates by Tony Parrott, Director of MSD. The Stormwater Policy Gap Analysis has been a collective focal point of the CFAC Policy Subcommittee from the start but became a greater focus beginning at the August 5, 2011 CFAC Policy Subcommittee meeting and discussed in more depth at the September 22, 2011 CFAC meeting.

MaryLynn Lodor, Environmental Programs Director at MSD, described the framework of the preliminary *Stormwater Policy Gap Analysis* and the background research used to inform the document. The September 22, 2011 CFAC meeting produced 10 storm water gaps that were suggested as a focus for the gap analysis. Hamilton County Planning and Development conducted another gap assessment using the Center for Watershed Protection's report called "Managing Stormwater in Your Community: A Guide for Building an Effective Post-Construction Program: Tool #4 – Post Construction Stormwater Management Codes and Ordinances Worksheet." Then, MSD and Hamilton County worked together to create a hybrid stormwater policy gap assessment by selectively merging the previous work of the CFAC and Hamilton County with the USEPA's "Sustainable Design and Green Building Toolkit for Local Governments." This hybrid was used to guide a three-hour stormwater policy workshop that gathered various professionals who closely work with the current storm water codes, rules and regulations. The meeting looked at over 50 separate storm water issues and best management practices (BMP), looking for codes and regulations currently in place that could impede or encourage the individual issue or BMP.

Brian Wamsley, Hamilton County Planning and Development, went through some of the individual gaps identified by the Preliminary Stormwater Policy Gap Analysis. The presentation was informal and allowed for questions, updates, clarifications, and all other types of comments during the presentation.

Discussion Highlights

The discussion was free flowing and covered many issues very quickly including the following main topics:

 - Post Construction Stormwater Management
 - o Illicit Discharge Detection
 - Soil and Erosion Control

- o Riparian Corridor Management
 - Near term solution for NPDES compliance Interim Development Control
 - Long term solution Land Development Code
- MSD Rules and Regulations
 - Section 514
 - MSD reimbursement to developers who do additional infrastructure work for MSD
 - Offset credit policy for stormwater infrastructure projects
- Need for Stormwater Best Management Practices Manual
 - o Proposed idea: MSD's Green Project Demonstration Program used to inform
 - o Proposed idea: Hamilton County Stormwater District and SMU collaborating on Design Manual
 - o Proposed idea: Light Imprint infused City Planning looking to address through LDC
- Remediation of Downspout Disconnection rules and regulation issues
 - Update: SMU has worked with Building and Plumbing Department and others on revisions to code
 - Next Step: Submit with or shortly after NPDES Ordinance revisions in December 2011
- Green Streets and Parking Lot Regulations
 - Curb-cut issues
 - Next Step: Continue to implement Pilot Projects as they arise
 - o Proposed idea: Long Term Land Development Code
- LID and BMP related codes, ordinances and incentive program gaps
